3. New registration by reciprocity: \$140.00 (\$50.00 application fee, \$45.00 first year of registration, \$45.00 background check fee).
4. Annual Renewal: \$45.00 CEUs are required.
5. Retired (emeritus): \$45.00 No CEUs required but can not work in career field.
